WHEREAS the Board of Student Ministry has \$2,000 dollars remaining in the Youth Ministry Development Fund, **BE IT RESOLVED** that the board gift \$500 to 4 churches for the use in student ministry to use at their discretion. These four churches will be Reed Point, Fallon, Circle, and Columbus.

WHEREAS this year's student ministry Annual Conference Training Conversation was a good forum, we believe that it would be better to bring in a speaker. **BE IT RESOLVED** that in 2013 we begin a search for someone around the topics of youth ministry pastoral care. **BE IT RESOLVED** that a list of possibilities will be brought to Spring Boards and decided on at that time.

WHEREAS the following was accomplished with the Fun Trailer: reformatting of Rental Policy & Procedure document, organization of equipment, installing combination locks, requiring a \$200 deposit for all rentals, online registration and calendar, adding replacement parts including harness, headgear, felt markers for bungee run, installing new tires on trailer, and adding a spare tire. **WHEREAS** the tires on the dolly are worn out, **BE IT RESOLVED** Roger Dayton buys and replaces these tires. **WHEREAS** the fun trailer is a great investment for the ministries of the Western Conference we do not yet have a good bounce house possibility for children's ministry. **BE IT FURTHER RESOLVED** that in 2013 we buy a bouncy boxing inflatable.

WHEREAS Michael Stambaugh has been the Fun Trailer Coordinator in Big Timber which is not logistically possible, **BE IT RESOLVED** Roger Dayton now becomes the Fun Trailer Coordinator.

WHEREAS Super Summer was \$3,000 dollars under budget **BE IT RESOLVED** that the Board funnel those funds into BMCR's Super Summer scholarship fund.

WHEREAS we believe the Pastor's and Wives Retreat is a great time to be with our wives **BE IT RESOLVED** we feel that a soul care retreat allows youth pastors time to come together to talk about youth ministry and unwind in a retreat setting, not only to have fun, but build community within the Conference youth pastors. **BE IT FURTHER RESOLVED** the Board will begin planning a Soul Care Retreat for 2013.

WHEREAS each year the Board sets aside money for youth pastors to travel and attend youth training events, and **WHEREAS** in 2012 no one requested to use this money, **BE IT RESOLVED** that each year we will appoint a church to send their youth pastor to these events. **BE IT FURTHER RESOLVED**, for the year 2013 the board of student ministries has selected Narrate Church to send representatives to a youth ministry event of their choosing.

WHEREAS our Conference is getting larger in area coverage and churches are needing to pick camps other than Super Summer to attend, **BE IT RESOLVED** that the travel budget for camp be extended to churches attending camps other than Super Summer to submit receipts by the end of August for reimbursement for travel.
